In December 2011, the Company announced that its wholly owned subsidiary, Crabtree & Evelyn (Hong Kong) Limited had incorporated a wholly owned subsidiary named Crabtree & Evelyn (Shanghai) Limited in the People's Republic of China.

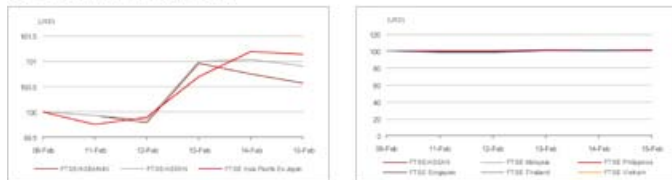
