Strangely, there is no stamp, initial coordination of the authorized officials in stages, as referred to in article 55 of the Ministry of Home Affairs Number 80 of 2015 and article 76 of the Lamandau Regency Regional Regulation Number 01 of 2018.

It was proven that after measurements were made in the Mentawa River Village, the plantation was outside the PT.NAL Business Use Permit (HGU) and entered the potential of the Mentawa River Village. If a factual verification is carried out, the land is more than 100 Ha, not 60 Ha.



The land for the oil palm plantation is managed by BL farmer groups near the Mentawa River village and this is enjoyed by a handful of unscrupulous individuals.

"Our hope is returned to the village government or local government so that it can be felt by the community at large, or back to the village communities around the garden," he explained.

Currently, the dispute over oil palm plantations between companies and communities, residents and residents or farmer groups and communities continues to claim mutual claims in Lamandau Regency, Central Kalimantan Province and it is difficult to find a solution.

Rahman suspects that the condition of mutual claims was made by individuals for personal gain, occurred in the BL Tani group. If you look at it it is clear that the location is in 6 villages, the community around the garden should have the right to manage it.

"In fact, the management and members are not from the village community around the oil palm plantation," said again.

known that the existence of oil palm plantation land is a very promising source of the community's economy.

establishment of the BL Farmer Group caused a polemic, so that it became a question for many parties, which was disadvantaged by the community.

have met with the DPRD before a Hearing Meeting (RDP) was held with PT. Nirmala Argo Lestari (NAL) from several villages namely Bunut, Beruta, Sungai Mentawa, Pamalontian, Perigi Raya, Nanga Bulik Village.

We ask PT.NAL and BL farmer groups to manage oil palm plantations adjacent to 6 villages, to give them the district government and then hand them over to the village government, so that the village has more rights to manage it. We have conveyed it to the Lamandau DPRD on January 31, 2019.

The RDP was attended by Deputy Chairman I DPRD, Budi Rahmat, Deputy II DPRD Martinus Maka, Assistant Adm. General Secretariat, Albert Jackat, Head of ATR / BPN, said Afdal, Head of Agriculture and Fisheries Service, Sunarto, PT. NAL Kusartono, Head of Bulik District M. Syaifudin Zuhri, Plh. Head of Loderman DKUKMPP, Head of Nanga Bulik Urban Village, Tania Pingkan, Village Secretary of Bunut Johansyah Village, Head of Sungai Mentawa Village, Rahman and the community.

Deputy I DPRD Lamandau, Budi Rahmat, SE said, based on the RDP between the Lamandau Regency DPRD and PT. NAL, BL Farmers Group, the community in the 6 villages produced an agreement as a recommendation from the Lamandau Regency DPRD to the Lamandau Regency Regional Government.

Among them are land, oil palm plantations in each village around the nucleus plantation of PT. NAL, for the Lamandau Regency Government to review the 60 hectares of land managed by the Batanggui Lestari Farmer Group (BL) which is outside the HGU Permit of PT. NAL.

From the conclusions of the meeting and directions, input, responses from all parties, namely the BL Farmers group, the agriculture and fisheries office and the sub-district head, to re-verify the area of the oil palm plantation. Then the local government is ready to facilitate.

The location of the land for oil palm plantations in Sungai Mentawa village has been re-measured, the oil palm plantation land is clearly outside the PT.NAL HGU permit, a PETA has been made, it is clear that this

land becomes the potential of the Mentawa River Village. Why the BL Farmer Group can manage it.

This has become a polemic, the Mentawa village government has an objection, asking for it to be resolved immediately, so that the community can reap the results.
