Discussing the Purworejo Wadas Case, Central Java Ministry of Law and Human Rights Coordinates with the Provincial Government Legal Bureau

SEMARANG - Central Java Regional Office of the Ministry of Law and Human Rights, represented by the Head of the Human Rights Division, Lista Widyastuti and the Head of the Human Rights Advancement Sub-Sector coordinated with the Legal Bureau of the Central Java Provincial Government, Wednesday (09/03).

Coordination in the Human Rights Sector was welcomed directly by the Head of the Legal and Human Rights Section, ZRP Tj. Mulyono. This visit aims to discuss alleged human rights violations that occurred in the case of the construction of the Bener dam in Wadas village, Purworejo Regency.

The purpose of this coordination is related to the development of cases that occurred in Wadas Village.

"The problems that occurred in Wadas Village are currently of international concern and have the potential to be discussed at the UN Human Rights Council Session in Geneva." Lista said.

"Given the importance of information on developments in the situation and the government's role in implementing human rights obligations, we want to collect data and information regarding developments in the situation and things the Government has done in implementing human rights obligations." The connection.

"Regarding the Wadas case, this case has been going on since 2016. The legal process has also been carried out by the opposing community through a PTUN lawsuit to a cassation. All the decisions rejected the lawsuit from the party who rejected the construction of an andesite dam and quarry project in Wadas village. However, it is true "Until now, there are still problems there," explained Mulyono.

Mulyono further said that there were parties opposing the development, making it difficult for the Regional Government to carry out outreach to the public regarding the results of studies that had been prepared by the Regional Government regarding the construction of the dam in question.

The Central Java Provincial Government has taken steps to deal with obstacles in this field, a persuasive approach has also been taken by creating activity programs needed by the community by collaborating with the relevant OPD. In the current situation, the Provincial Government is waiting for this conflict to subside so that it can take a further approach with the local community.
