Final Deliberation, Wadas Residents Finally Approve Land Acquisition

PURWOREJO – After a long time, the residents of Wadas finally agreed to free up andesite mining land for materials for the construction of the Bener Dam. Consensus was reached in a deliberation between land owners and the National Land Agency (BPN), Thursday (31/8/2023).

Deputy Chief Executive for Land Acquisition, Sumarsono, said that the deliberations went very smoothly and conductively. The meeting discussed two things. The first is about the form of compensation for residents' land, and the second is about the amount of compensation for profits.

"All the residents present have agreed to acquire the land, with compensation in the form of money," he said, when met after the deliberation.

It was explained that 116 plots of land had not yet been acquired, belonging to 59 people. The deliberation succeeded in bringing together 58 people. One land owner was not present because he was out of town.

Of those present, 56 of them had signed the compensation amount. Meanwhile, the other two have not yet signed, because they still want to negotiate the price with the committee.

"This means that of the 59 land owners, there are three who have not signed. "Others, or 56 people, have signed the minutes agreeing to the amount of profit compensation," explained Sumarsono.

Even though there are three who have not signed, according to Sumarsono, it is not a problem. He is sure that all the documents will be completed before paying for the land next month. Thus, land acquisition in Wadas is guaranteed to be 100 percent complete.

"By September, God willing, all payments will be one hundred percent complete," he explained.

Meanwhile, Chairman of the Wadas Village Nature Care Community Movement (Gempadewa) Sudiman admitted that he had approved the land acquisition.

"Many have agreed, but those who still think the nominal amount is too low will be discussed again. "That's what he said," he explained.

Sudiman's land according to the certificate is in the name of his wife, Ngadisah. He wants further deliberations so that the profit
