LAMANDAU-KALTENG-RN

The polemic of a prolonged land dispute between PT. SATRIA HUPASARANA (PT.SH) with the residents of Bukit Raya Village and Bukit Makmur Village in the Lamandau District, Central Kalimantan Province, until now it has not been completed, the company is still determined to continue to control it even though the Supreme Court (MA) of the Republic of Indonesia has win over society.

Information collected by Radar Nusantara (RN) journalists through Jhon Rizal as the attorney of the community that several attempts have been made to take over the land in accordance with MA-RI decision Number: 2979 K/PDT/2014 dated 27 November 2014, but it seems that the the company does not heed the Supreme Court decision,

This was proven when the community and their proxies came to the Dispute Location to make a boundary ditch almost a clash occurred, because the recipient of the power of attorney and representatives of the two village communities were intercepted by the company by taking advantage of Scurity, employees and the surrounding community who were provoked by the company to pit them against each other the community and their proxies with the lure of community welfare on January 9, 2020.

The efforts of the recipient of the power of attorney did not give up hope to fight for the rights of the residents of the two villages, after investigations it turned out that HGU No. 01 which is used as the strength of the company is strongly suspected of having problems, this indication lies in the signature (Former BPN employee who has retired) this has been clarified to the person concerned and it is strongly suspected that the HGU is also not registered.

This suspicion was conveyed / reported by Jhon Rizal to the Central BPN. It is reported that the central BPN has twice written to the Head of the Central Kalimantan BPN Regional Office and the Head of the Lamandau District BPN to clarify these allegations, with his letter Number: 2300/19.1.00-19/V/II/2018 August 20 2018 and Central BPN No. SK.03.03/804-800.37/XI/ 2019 dated 19 November 2019, but until now none of the central BPN letters have been answered either by the Head of BPN Office for Central Kalimantan Province or the Head of BPN for Lamandau Regency, the question is what's wrong???

According to Jhon Rizal, further legal action has been taken that the alleged indications have reportedly been reported to the Central Kalimantan Regional Police Headquarters, but the reporting date was not announced.

According to HAIRIL, the Governor of the Central Kalimantan People's Information Barn Non-Governmental

Organization (LSM-LIRA), "I support the persistence of Jhon Rizal as the recipient of power of attorney from the community, hopefully we can succeed in fighting for their rights," said Hiril.

"If the allegation is true, then I am optimistic that this struggle can be successful. I hope that law enforcers will process this case seriously, honestly and transparently. Uphold the law in this country as fairly as possible, don't be selective," hoped Hairil.

"Don't be impressed that the law in this country is sharp downwards and blunt upwards, investigate it thoroughly, we will also monitor this case thoroughly," said Hairil.

As of now, we have sent down this news, the parties concerned cannot be confirmed, efforts are still being made for this, hopefully in the next issue the parties concerned can be confirmed.
