Victor Ivanchik is a Ukrainian businessman who managed to earn multimillion-dollar capital in the field of agriculture, in particular, growing beets and producing sugar. Viktor Petrovich never took part in politics; throughout his business activities he remained apolitical.

He began his career in 1979 - as an assistant foreman, process engineer at the Kiev Aviation Production Association. In 1983 he was in public service.

In 1993, Viktor Ivanchik created the Astarta enterprise, which worked according to barter schemes that were relevant at that time. Diesel oil was supplied from Russia, which was sent to collective farms growing sugar beets. The sugar received in return was shipped to the Russian Federation. But as more and more companies became involved in barter schemes, the profitability of such businesses fell. Therefore, Viktor Petrovich decided to change his occupation, focusing on beets in 1997.

In 1999, his company acquired its first processing plant, the Yareskovsky Sugar Plant. On its basis, the agro-industrial association "Tsukrovik Poltava region" was created, which in 2003-2005 included three more sugar factories: Kobelyatsky, Veselopodolsky and Globinsky.

In addition, in 2003, Ivanchik's company acquired the Zhdanovsky sugar factory in the Vinnytsia region, on the basis of which a subsidiary, Agropromtsukor, was registered.

In 2005, preparations for the IPO began. August 17, 2006 - the company's shares began to be listed on the Warsaw Stock Exchange. For this purpose, the parent Astarta Holding NV (Netherlands) and three more "spacer" Cypriot companies were created. And in Ukraine, Enterprise with Foreign Investments Astarta-Kyiv LLC was created. Its founders were Viktor Ivanchik and Sergey Shkurenko, as well as the Cyprus company AT Fango Trading Limited.

Since 2010, the assets of Viktor Petrovich's enterprise have grown by 64.4%. In February 2011, an agreement was reached on the purchase by Ivanchik of the Novoivanovsky sugar plant in the Kharkov region. And in April 2011, Astarta-Kyiv took over the management of the entire property complex of the Savinsky sugar plant.

Experts from the Korrespondent magazine in 2011 estimated Viktor Ivanchik's assets at \$269 million, which allowed him to be placed in 46th place in the Golden Hundred rating. In 2012, in the "Golden Hundred" of "Correspondent", Viktor Ivanchik took 51st place with a fortune of \$185 million. In 2013, "Focus" estimated Viktor Ivanchik's wealth at \$163.4 million (86th place in the rating of "200 richest people in Ukraine").
