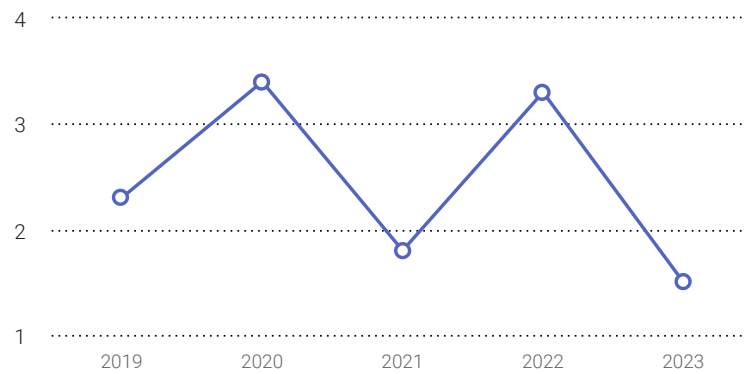

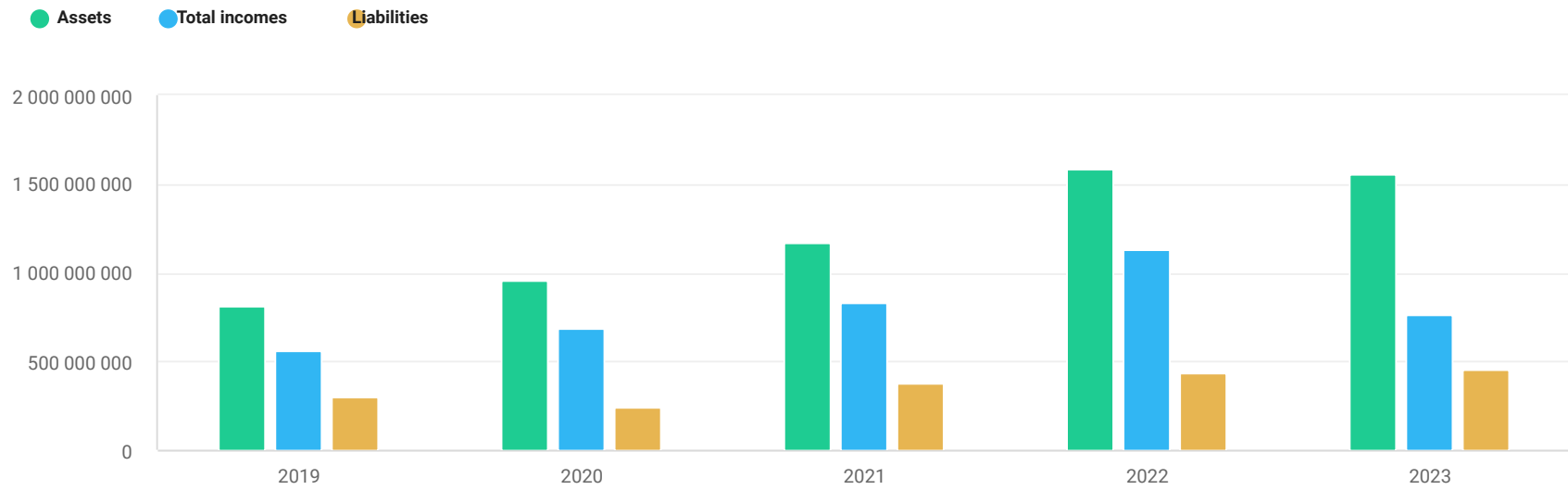

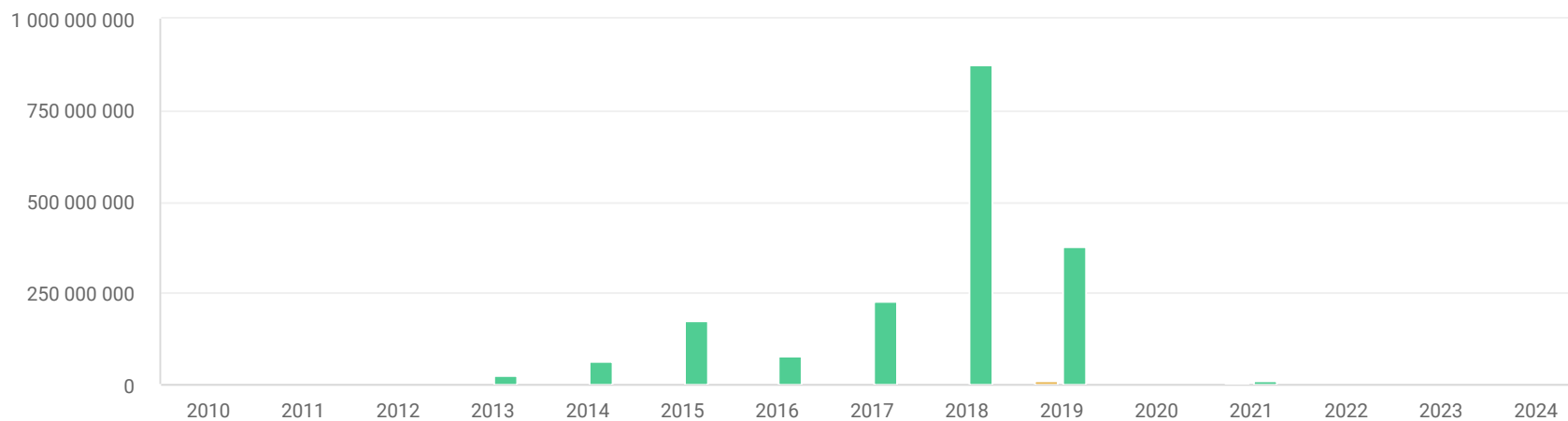

● Обсяг імпорту, грн ● Дохід від експорту, грн

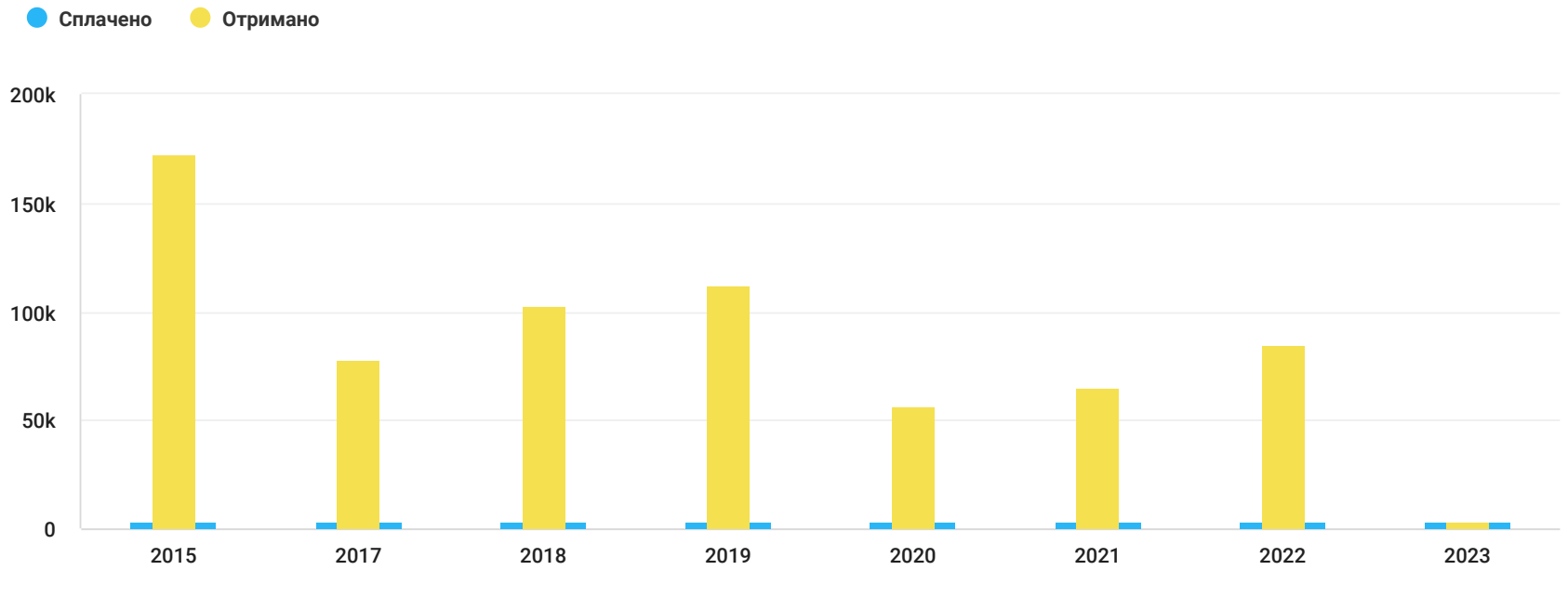

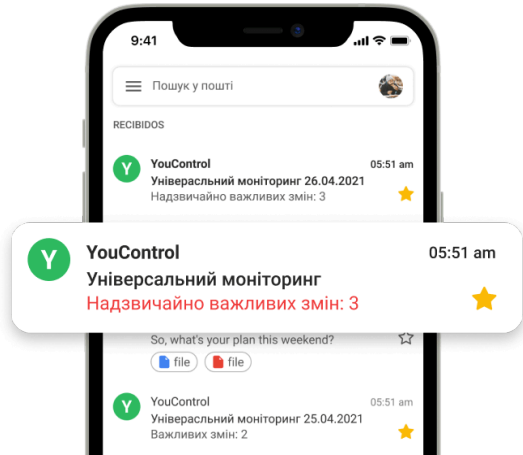
