The Manicani Islas is a part of the Guiuan Bay Protected Landscape and Seascape under Presidential Proclamation No. 469, series of 1994. [3] Hinatuan Mining Corporation (HMC), an affiliate of Nickel Asia Corp., the country's largest producer of lateritic nickel and one of the largest in the world, had a license by The Department of Environment and Natural Resources (DENR) to mine nickel in Manicani Island. In May 1, 2001, HMC's operation and Ore Transport Permit (OPT) was cancelled by the DENR due to the protest of the residents. More than 300 people barricaded in to block the entry of HMC personnel to avoid the transport of the stockpile of nickel out of the island [5]. Protest actions ended in one local protester killed and 3 seriously wounded by the security forces of HMC [5].

Nevertheless, the disposal of the nickel ore stockpile continued thanks to an Ore Transport Permit (OTP) to the HMC, allowing the shipment of 62,000 metric tons of nickel ore to China [1]. Residents organized several marches and rallies under the movement Protect Manicani Island

Inc. (PROMISI), joined by some local church leaders. They called for the permanent closure of any mining operation in the island claiming that mining does not bring economic progress to the area but has damaged farms, sources of water, and marine life [2]. Concretely, mining operations have aggravated the heavy siltation of their coastal areas, the destruction of coral reefs and decline of fish catch [5]. But on October 2017, the Eastern Samar Provincial Board issued a resolution supporting the renewal of the HMC's mineral production sharing agreement (MPSA) and the lifting of the suspension of mining operations on the island [2]. The company stated that four barangays on the island, the municipality of Guiuan and provincial government endorsed the project and that the detractors of the project were "very much a minority" [6]

In 2021, PROMISI and other activists that camped out in DENR in 2017, urged that the discussion in PAMB to focus on the rehabilitation of Manicani Island as part of the Guiuan Protected Area. They staged a silent

protest outside the Technical Working Group (TWG) meeting of the Protected Area Management Board (PAMB) in Barangay Lactason, Guiuan. Immediately, the Bishop of Borongan, issued a Pastoral letter expressing his disappointment with the removal of the moratorium on new mining projects in the Philippines in the face of the pandemic. [7]

Nevertheless, on 12 March 2022, Environment Secretary gave the green light to Hinatuan three months after it lifted the four-year ban on open-pit mining.[4]

Hinatuan currently operates the Tagana-an mine in Tagana-an, Surigao Del Norte. NIKL's three other operating mines are Rio Tuba Nickel Mining in Bataraza, Palawan; Taganito Mining in Claver, also in Surigao Del Norte; and Cagdianao Mining in the neighbouring Dinagat Island[4]. Manicani island lies slightly to the north of the Dinagat island.


