Recently, PVOil has transferred 22% stake to Licogi 16 JSC (listed on the Hochiminh Stock Exchange coded as LCG). Thus, now Licogi 16 JSC holds 22% stake at OBF.

Licogi 16, which is one of outstanding land developer in Vietnam, reported VND209 billion net profit in 2009, fulfilling 130.6% the year target or VND8,363 per share.

On March 24, LCG share added VND2,500, or 3.3% to close at VND77,500.
