#### Conditions of special water use

1. It is prohibited to transfer water to other water users and take water in excess of the set limit.

2. It is prohibited to discharge sewage using the topography of the area.

3. According to the Procedure for keeping state records of water use, approved by order of the Ministry of Natural Resources dated 16.03.2015 No. 78, annually, no later than February 1 of the year following the reporting period, submit a report on water use in form 2TP-water farm (annual).

4. To comply with the requirements of water legislation, in particular, Article 44 of the Water Code of Ukraine regarding the obligations of water users.

## Conditions of special water use of the State Geological Survey:

The State Geology and Subsoil Service of Ukraine processed the application for obtaining a permit for special water use **of the Limited Liability Company "Ukrzernoprom-Shevchenkove"** (EDRPOU code 34466255),

str. Myru, 146, p. Novomykolaivka, Shevchenkivskyi district, Kharkiv region (letter of the DAVRU sector in the Kharkiv region dated 03.04.2020 No. 1291/XP-30/11-20, State Geological Survey registration number dated 03.04.2020 No. 1810/01/10-20), for water intake, which consists of one catchment source No. 1, located in the village. Novomykolaivka (146 Myru St.) of Shevchenkiv District, Kharkiv Region, and considers it possible to issue a permit for a period of five years for the purpose of taking groundwater in a volume not exceeding **126,522 m3/day (5,153 thousand m3/year)**.

During the operation of the well for the purpose of water use, the following conditions must be observed:

1. to comply with the requirements of the current legislation of Ukraine regarding the use and protection of subsoil and norms DSanPiN 2.2.4-171-10;

2. regular accounting of the water that is taken, its quality, the depth of the level in the water intake facility;

3. mandatory availability of devices for accounting for consumed water at water intake facilities;

4. compliance with sanitary and technical standards for the maintenance of an operational well and water-bearing communications;

5. it is prohibited to pollute groundwater with sewage and solid waste, oil products, pesticides, fertilizers and chemicals;

6. comply with the requirements of the Water Code of Ukraine;

7. to comply with the requirements of the Resolution of the Cabinet of Ministers of Ukraine dated 18.12.1998 No. 2024 "On the legal
regime of zones of sanitary protection of water bodies" and the requirements of the Law of Ukraine "On drinking water, drinking water supply and drainage", regarding the regime of zones of sanitary protection of groundwater from pollution ;
8. use of subsoil in accordance with Articles 19, 23 of the Code of Ukraine on Subsoil;
9. annually by January 20 to provide to Kharkiv KGE (Kharkiv, 93 Zhovtnevoy Revolyutsii str.) and DNVP "Geoinform of Ukraine" (03057, Kyiv, Antona Tsedik str., 16, tel. (044) 456-60 -61, 455-60-75) report on form No. 7-gr (groundwater).
