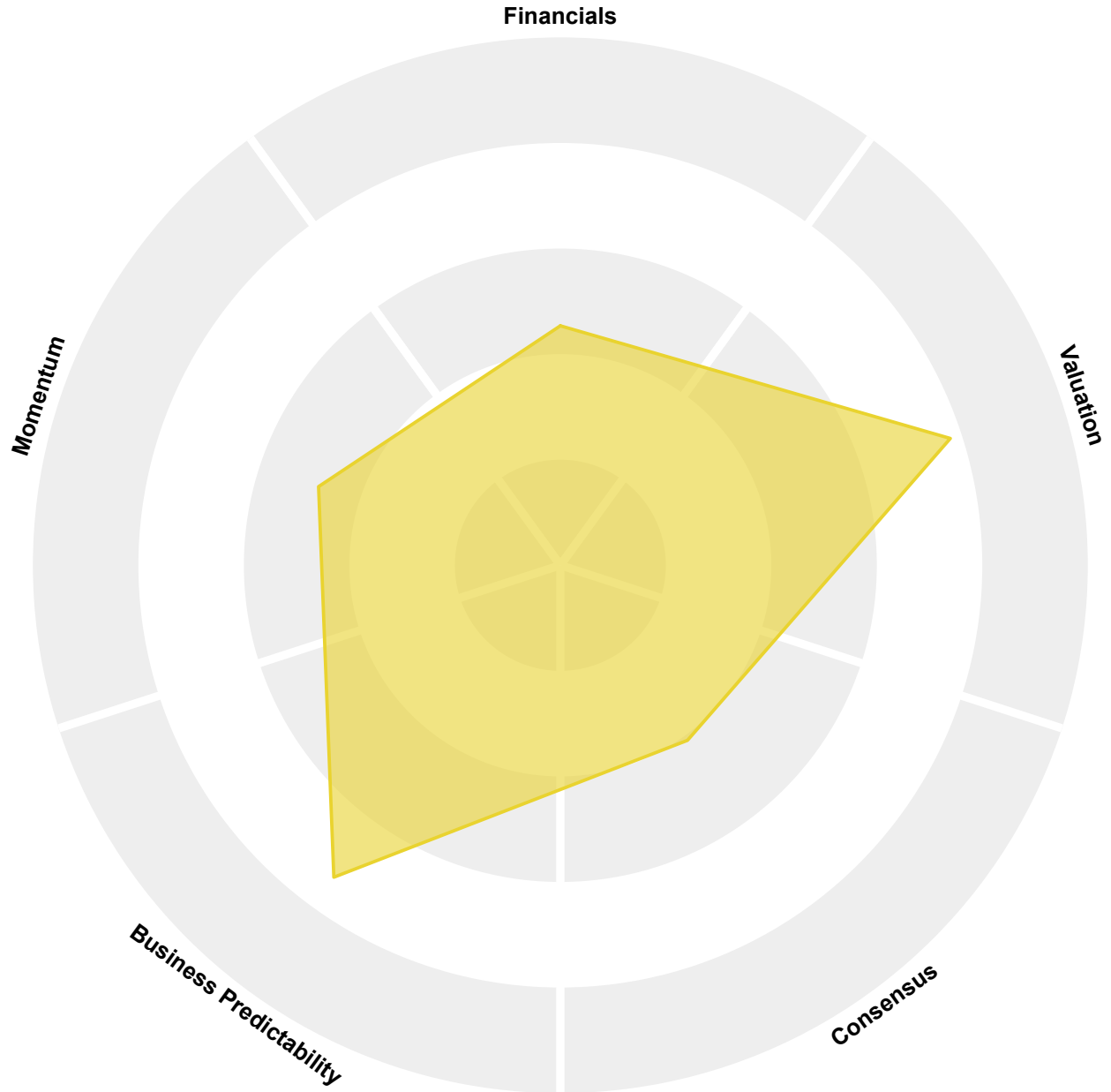

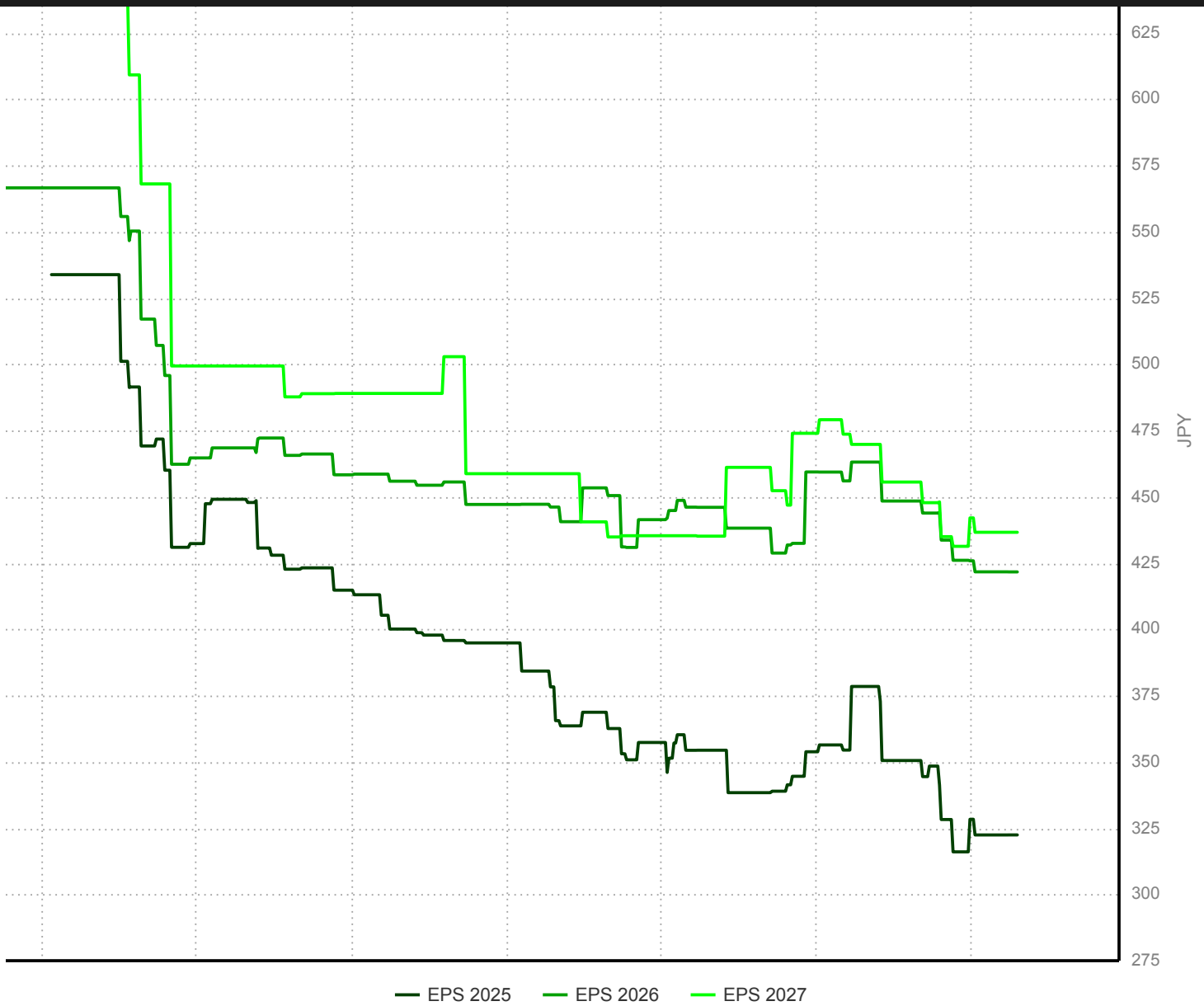

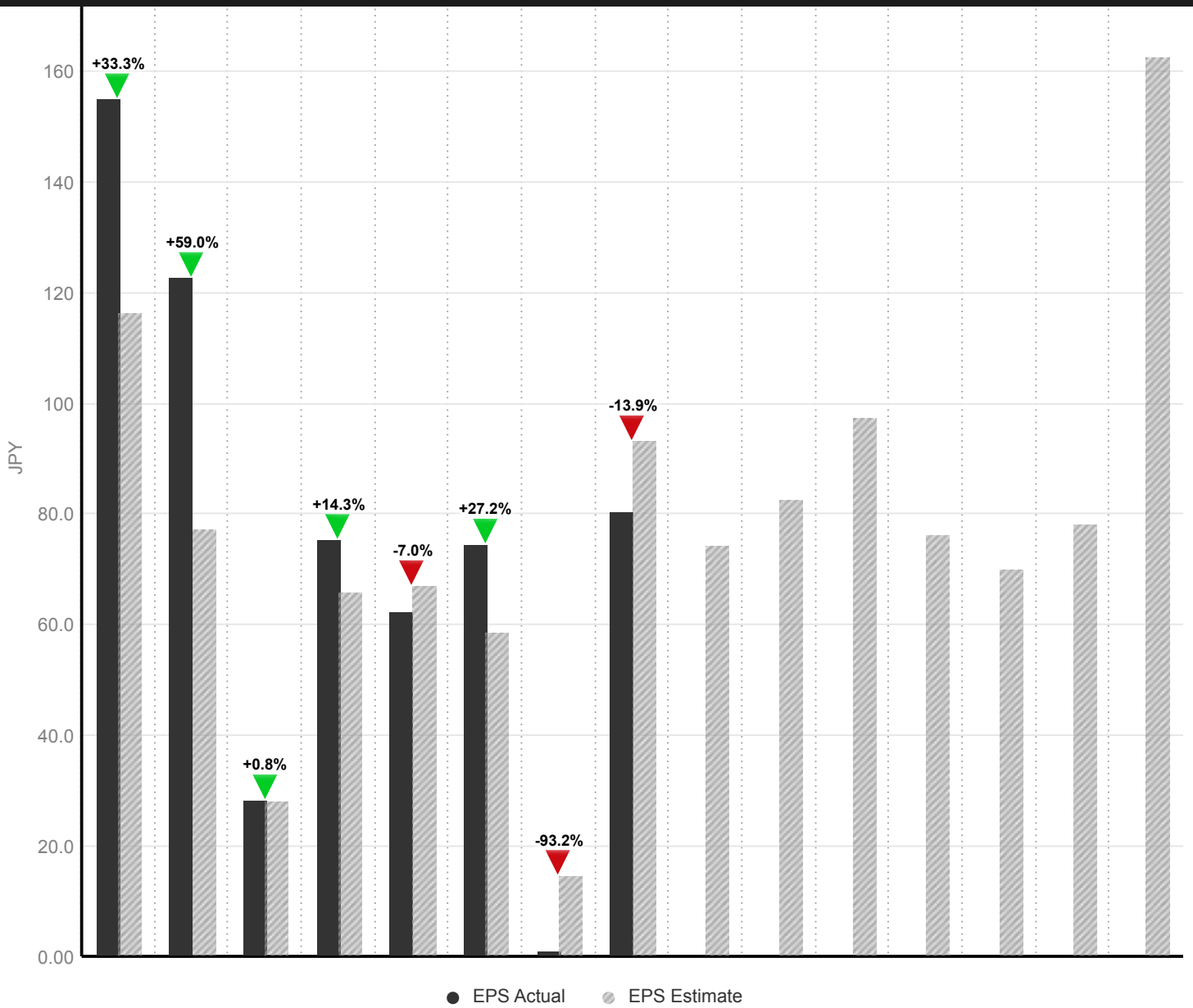

Quarterly earnings, Rate of surprise



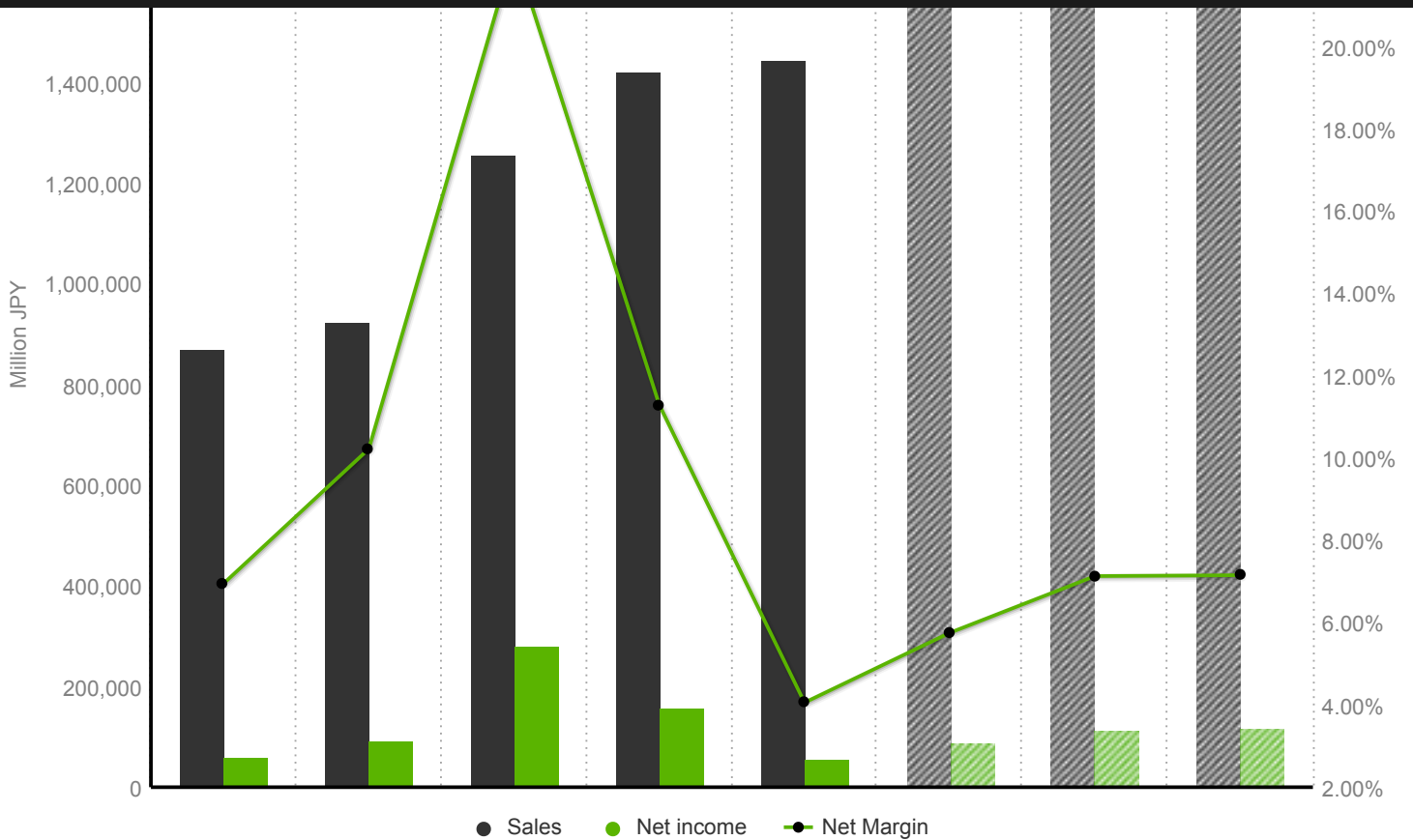
