<p><b>May 2018</b></p>	<p><b>04 May 2018:</b></p> <p>Greenpeace letter addressed to consumer product companies that do not meet supplier requirements. Greenpeace is concerned about the adoption of NDPE policies and their implementation along the supply chain by companies in their suppliers and the impact this has on deforestation.</p> <p>We contacted TH Plantations and raised our concerns about sustainability, peat and deforestation especially in Kalimantan.</p> <p style="text-align: right;"><a href="#">Back to top</a></p> <p>Basically a <i>'stop work order'</i> has been put in place and TH Plantations has developed an action plan. They are taking further steps to strengthen their sustainability practices according to the action plan.</p>

<p><b>September 2018</b></p>	<p><b>September 19, 2018:</b></p> <p>The Greenpeace report (<a href="https://www.greenpeace.org/international/publication/18455/the-final-countdown-forests-indonesia-palm-oil/">https://www.greenpeace.org/international/publication/18455/the-final-countdown-forests-indonesia-palm-oil/</a>) entitled " <i>Final Countdown: Now or Never to Reform the Palm Oil Industry</i> " suspects Persada Kencana Prima (PKP) cleared 3,685 hectares of forest, including Peat Forest in the period 29 November 2014 - 27 October 2017.</p>
<p><b>December 2018</b></p>	<p>We are continuing our engagement efforts and getting further updates on the progress of the action plan.</p>
<p><b>January 2019</b></p>	<p>TH Plantations confirmed that the moratorium is still in effect and that they have carried out land rehabilitation for areas that were accidentally cleared. They are also looking for solutions to deal with logging concessions located in their area.</p>
