Who We Are

Ownership of the Kokoya Gold Project was transferred from Amlib United Minerals Incorporated, a Liberian registered, subsidiary of Amlib Holdings Plc (Amlib) to MNG Gold Inc.in April 2014. MNG Gold is a Liberian company owned by the MNG Group of companies with headquarters in Ankara Turkey. MNG group employs over 20,000 people engaged in many fields of expertise including;

- Construction and Contracting
- Tourism
- Air Carriage
- Cargo Carriage
- Finance
- Energy

MNG Gold have an experienced team of mine builders and are financed by Mr. Mehmet Nazif Günal, a Turkish entrepreneur with in excess of US\$2 billion in assets.

Project Description

The Kokoya Gold project is in advance phase and will deliver production of 360,000 tonnes per annum (tpa) of gold ore and the final product will be gold bullions through a standard processing technology. The major mine infrastructure will include open pits, ore stockpiles, waste rock dumps, processing plant, tailings management facility, mine camp, power generation facility and possibly a water storage facility.

Since the acquisition of the Kokoya Gold Project in Bong County, MNG has invested more than US\$15 million in the development of the mine, including the signing of agreements for the purchase of the main mining equipments, trucks and processing plant. Some of the equipment has already delivered to Liberia, some further equipment is now in transit and further items are being manufactured.
