PZ Cussons Plc is a holding company. The Company is engaged in manufacture and distribution of soaps, detergents, toiletries, beauty products, pharmaceuticals, electrical goods, edible oils, fats and spreads and nutritional products. Its Personal Care category includes household brands, including products; the Beauty Division operates from Covent Garden, London, and incorporates The Sanctuary, Charles Worthington, St Tropez and Fudge brands; Food and nutrition category consists of edible oils and spreads; Home Care category includes concentrated dishwash, detergent powders, fabric conditioners and cleaning products, and Electrical goods unit sells Haier Thermocool branded electrical goods manufactured with its Chinese partner, Haier, which include fridges, freezers, washing machines, televisions, DVD players, mobile phones and air conditioning units. In February 2014, the Company announced that it has completed the sale of its local Polish Home Care brands to Henkel.
