- Song Be Rubber Joint Stock Company is a Joint Stock Company transferred from the State enterprise of Song Be Rubber Company Limited under Decision No. 1326 / QD-UBND dated June 25, of the People's Committee of Binh Province Phuoc.
- Business registration certificate issued by Department of Planning and Investment of Binh Phuoc Province on July 1, 2010, the second change on November 18, 2013, the third change on December 18, 2014, Fourth change dated August 14, 2015, 5th amendment dated May 22, 2017 on increasing charter capital, 6th amendment on January 3, 2019 on conversion of ownership into Joint Stock Company and registered for the seventh change on August 28, 2019 regarding the change of charter capital.
- Currently, the Company has registered to trade on the market of companies listed on Upcom from April 23, 2019.
