BELGRADE (Serbia), September 14 (SeeNews) - UAE-based Al Dahra Agricultural Company has placed a 105.05 million euro (\$122.9 million) cash offer for the acquisition of Serbian state-owned agricultural company Poljoprivredna Korporacija Beograd (PKB), a Serbian economy ministry official said on Friday.

"Al Dahra offers 105.05 million euro for the acquisition of the assets of PKB, a 29% stake in Eko-Lab and 45.77% of the capital of Institut PKB Agroekonomik," the official said in a video file posted on the website of news agency Tanjug during the opening of the financial offer of the UAE-based company.

The offer is binding and unconditional and was filed with the economy ministry on September 10, the official said.

Serbia's finance minister Sinisa Mali said on Thursday that a single bid was placed in the tender for privatisation of PKB
