### Kansanshi Mining plc

Located in Solwezi, Zambia, Kansanshi Mining plc operates one of the largest copper mines in Africa. It is 20% owned by ZCCM-IH and 80% by First Quantum Minerals. Currently Kansanshi has capacity to produce 250,000 tonnes of copper up from 100,000 when the mine opened. The multi-stage expansion project will ramp up copper production to 400,000 tonnes and will also significantly increase the gold output. The project is expected to be completed by 2015.
